## About the Conclave

Introduction of the Goods and Services Tax (GST) in India marked a significant structural reform aimed at unifying the indirect tax regime and promoting economic efficiency across sectors. This seminar proposal examines the sectoral growth trajectories of agriculture and other major sectors in the post-GST period, with a focus on understanding how the new tax architecture has influenced production, market integration, supply chains, and overall sectoral performance. While agriculture remains largely outside the GST framework, the sector is indirectly affected through taxation on inputs, logistics, and agro-processing activities. The seminar explores how these indirect effects—such as streamlined transport, reduced inter-state barriers, and more formalized value chains—have shaped agricultural competitiveness, market access, and cost structures.

Beyond agriculture, the proposal assesses sectoral responses in manufacturing, services, MSMEs, and trade. GST's impact on ease of doing business, compliance requirements, and digital integration (through e-way bills and input tax credit mechanisms) has generated differentiated outcomes across sectors. Manufacturing and logistics have benefited from reduced tax cascading and improved operational efficiency, whereas MSMEs have experienced mixed results due to compliance burdens despite broader market opportunities. The services sector, a major contributor to GDP, has undergone tax rationalization but continues to face challenges in classification and rate structures.

Using secondary data, policy documents, and empirical studies, the conclave aims to evaluate whether GST has fulfilled its objectives of promoting growth, enhancing tax transparency, and strengthening the national market. It will also discuss sector-specific challenges, transition issues, and the uneven pace of adaptation across industries.

Overall, the conclave seeks to provide a comprehensive assessment of post-GST sectoral growth, highlighting the interplay between tax reforms, structural shifts, and economic performance. The insights derived will support policymakers, researchers, and industry stakeholders in understanding the long-term implications of GST on India's agricultural and non-agricultural sectors.

## About Ri-Bhoi College

Ri Bhoi College, is nestled in the scenic town of Nongpoh, the headquarters of Ri Bhoi District Meghalaya.
